**TRUSTEE'S SIXTH MOTION TO STRIKE OR RECLASSIFY CLAIMS**

**COMES NOW**, Daniel G. Hamm, Trustee for the above Chapter 7 case, and shows unto the Court that, pursuant to *11 U.S.C. § 507(a)(8)* and *3007(d)(1) Fed. R. Bk. Proc.*, claims 1-29 are due to be stricken or reclassified.

The Trustee moves to increase those claims, having supporting documents that reflect a larger claim amount than listed on the Creditor's Proof of Claim. The Proof of Claim Numbers listed on this Motion comes from the Claims Registry listed with BMC Group. The Trustee moves to decrease those claims where supporting documents reflect a lower claim amount than listed on the Creditor's Proof of Claim. Furthermore, the Trustee moves to reclassify the amounts claimed by the Creditors up to \$2,600.00 as priority, in compliance with *11 U.S.C. § 507(a)(8)*, and the balance of any claim in excess of \$2,600.00, as a general unsecured claim.
